

## Costs

- One time House Arrest hookup fee - \$35.00
- County jail inmate fee - \$10.00 per day
- Electronic Monitoring/House Arrest fee - \$10.00 per day

## Determining Eligibility

- No history of violent or sex crimes in the past 10 years, unless waived by the Court or District Attorney.
- Must be a Huntingdon County resident.
- No accidents involving death or serious bodily injury.
- Other criteria will be reviewed in the application process.

*Intermediate Punishment  
Program*

## ***Why was this program designed?***

This program was designed to help offenders who would otherwise be incarcerated in the Huntingdon County jail to keep their jobs, obtain treatment, and otherwise lead a fairly normal daily life. Those accepted into this program will be required to fulfill the requirements of the program including participating in treatment, attending appointments, and completing community service hours ordered by the court.

Consequences are imposed for program violations. Major violations can result in your being incarcerated and brought back before the court for resentencing.

## ***What is Intermediate Punishment?***

This program is a restrictive program with a high level of supervision, but it allows for those employed to keep their regular work schedule, and those unemployed to obtain employment or education

Other components are:

- A sentence to either a maximum of 90 days in jail or house arrest in some cases a combination of both, followed by a period of probation.
- Intensive supervision by the Probation Department
- Random drug/alcohol testing,
- A treatment requirement determined by a licensed drug and alcohol provider.
- Cooperation with the terms and conditions of the Probation Department.
- Community service hours
- Electronic monitoring and/or alcohol monitoring system house arrest equipment.
- Payments for house arrest and electronic monitoring are paid in advance.
- Other components will be explained in detail after acceptance to the program.

## ***What are the Benefits?***

- Reduce your jail time
- You stay within your own home rather than the jail
- You may continue your employment and work a regular schedule
- You will be receive towards the treatment you need to help prevent future arrests.

## ***How to Apply?***

The application process is as follows:

- An application will be provided by your attorney or obtained online from Huntingdon County webpage.
- The completed application will be submitted to the Probation Department
- The application will be reviewed by the Probation Department.
- Application will be approved or denied by the Probation Department or District Attorney according to the eligibility requirements.
